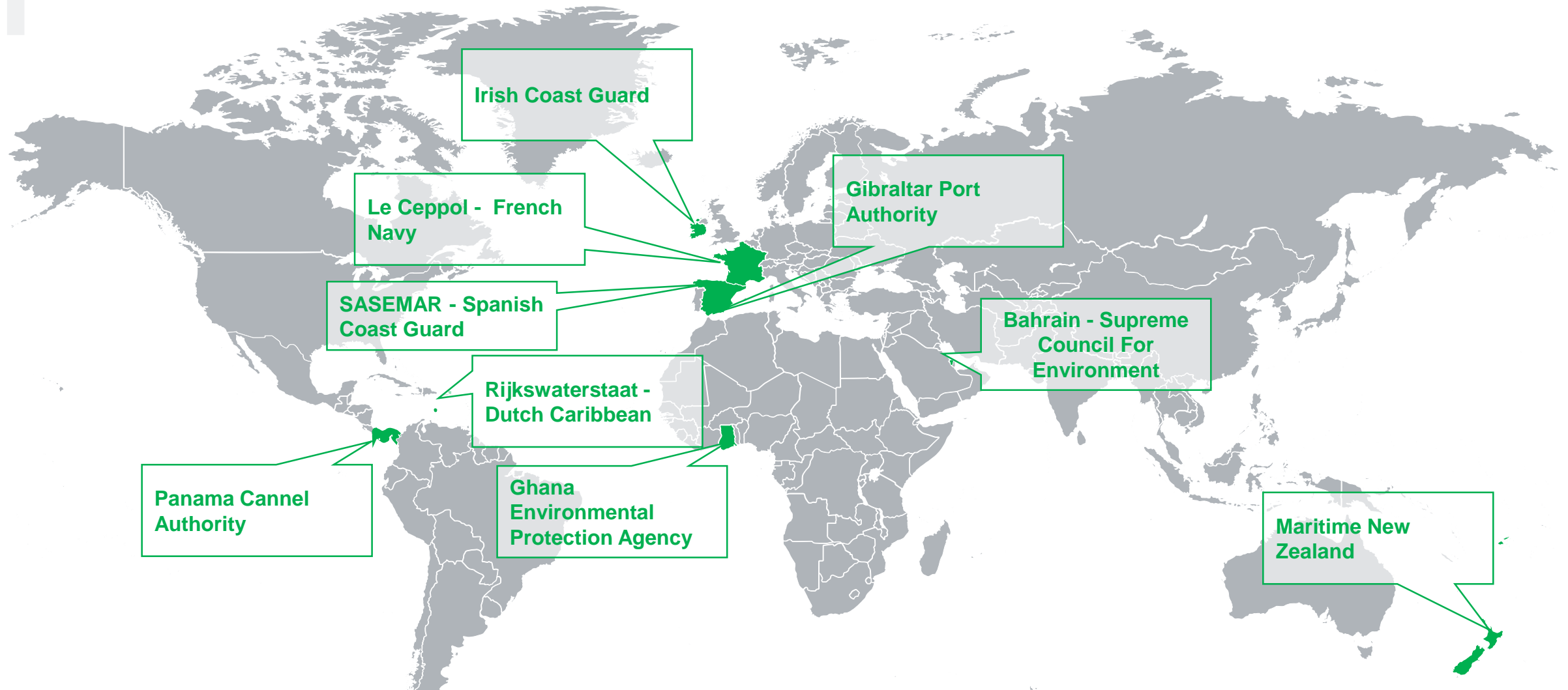


OSRL - Our Shareholders

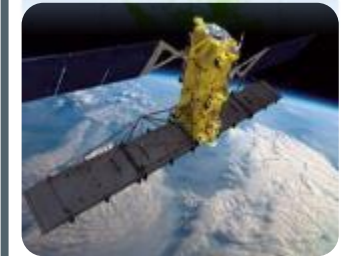
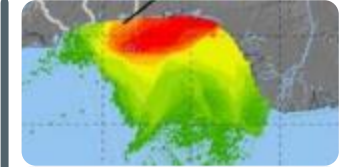

Enhancing Capability for the Pacific Island Countries

Working Together

- > Oil Spill Response Limited (OSRL), the Secretariat of the Pacific Regional Environment Programme (SPREP), Maritime New Zealand (MNZ) and New Zealand Ministry of Foreign Affairs and Trade (MFAT) have agreed a mechanism to efficiently increase oil spill response capability for the Pacific Island Countries and Pacific Island Territories.
- > This new mechanism will enhance the capability that exists at national level and complement other resources that are made available through intergovernmental arrangements, by providing each of the Pacific Islands Countries and Island Territories with direct access to OSRL's global oil spill response

How it Works

The planned approach

- > SPREP plans join OSRL as an Associate Member and will pay the annual subscription fee directly to OSRL
- > MFAT agree to sponsor the funding of the Membership
- > On agreeing to the terms of the Membership and signing the Associate Agreement as a “Mobilising Party”, each of the Pacific Island Countries / Island Territories will have direct independent access to OSRL’s response services
- > In the event of an oil spill incident or imminent threat of an incident, the affected Pacific Island Country or Island Territory can call upon OSRL to respond through their nominated call out authority
- > The Mobilising Party will pay OSRL directly for response services based on OSRL’s standard membership rates (see Scale of Fees). NB Up to 5x Technical Advisors are free of charge for up to 5x days on site
- > The scope of supply defined in the “Service Level Agreement” will be available on a per incident basis, i.e. if a single oil spill event affects more than one Pacific Island Country or Island Territory, then the resources will be shared by those Parties.
- > SPREP can renew the Membership on an annual basis on behalf of the Pacific Island Counties and Island Territories
- > On finalising the Membership with OSRL (target Q1 2020) OSRL will hold an Integration Workshop for the Parties to share a greater level of detail on the services, mobilisation, response procedures and processes, roles and responsibilities of each party. NB workshop tentatively scheduled for 1st week April 2020 in Solomon Islands
